CHAIRPERSON'S REPORT

2014

In the past twelve months the centre has grown with new groups established. We have over 2,365 people visiting the centre every month to access the services that are available.

The Study Buddies program continues at the centre with approximately 8 children attending at various times. This program is very popular with both the parents and the children. The Community Development Worker, Suzanne has created a positive and trusting environment for the children to complete their homework. Because of funding short falls, it has become a challenge to continue with this program. We will continue looking for opportunities in raising funds to continue this worthwhile program into the future.

The Community Services Network Group has become stronger after conducting their 4th successful Neighbourhood Week Event; this was held over a 5 day period. Meeting monthly to plan for the Neighbourhood Week event has helped to develop, networks, partnerships and the sharing of resources and information. The group will work towards ongoing planning for next year's event.

The John Irving Park Community Garden has been granted an extra block of land next door to the garden. However part of the land is contaminated, Parramatta City Council have kindly agreed to remediate the land in preparation for the gardeners to use. This will give the gardeners an opportunity to expand the garden providing more plots to other members of the community who are currently on a waiting list.

I would like to thank the outgoing Management Committee and volunteers for their support and commitment through the past year. A special thank you, to Mary Molloy and Ian Macleod for their on-going support. Ronda Evenden for her dedication and commitment in raising the profile of the Harris Park Community Centre

I look forward to welcoming the new committee and wish them all the best with the challenges and successes for the future.

HIGHLIGHTS FOR 2014

Thank you also to the community members who have supported us in attending our events, assisting in developing programs and projects.



I look forward to the challenge of expanding towards a bigger, brighter and productive future as we work together in providing much needed services in Harris Park and surrounding areas.

Community Development, Information, Referral & Material Aid

The Harris Park Community Centre was established to support children, youth, individuals, families and the disadvantaged in our community, so they can enhance their independence, safety, self esteem and/or quality of life; building strong communities, social capital and undertaking community development so that communities are well resourced, connected, where equity and diversity are embraced.

Listed below are the activities completed during the period 2013 / 2014.

29,102 community members entering the premises were assisted with information, referral and resources, this figure includes the groups and Justice of the Peace clients. The community is becoming more aware of the centre and the services we offer due mainly to the successful events held over the year. Next year with the development of our website the community will be better informed and resourced.

Approximately 93% of those assisted required crisis / short term case management due to extreme circumstances.

405 community members were assisted with food parcels.

1,000 quarterly newsletters were hand delivered by our volunteers and collected from the centre. We have developed a large email list of community members and organisations, who are interested in being on our email list.

The Harris Park Community Centre newsletter offers information about local support and activities of the centre; the newsletters are distributed four times in the year to households, business's and organisations in the Harris Park / Rosehill areas. This strategy has proven very successful with an increase in community awareness and involvement and is a great opportunity to advertise the centre and activities.

Parramatta Free Boot Camp

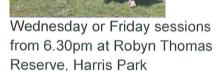
This year we were approached by Parramatta City Council Recreation Program,

to auspice a free boot camp. This means that we agreed to provide insurance with Parramatta City Council providing the funding. The trainers are all qualified Fitness Instructors who are keen fitness enthusiasts and are passionate about community



and fitness. They saw a

need within the community but didn't want to exclude anyone because of financial barriers, so decided to provide this service for free. They have over 30 or more, community members attending on Monday,



Next year we will need to look for other avenues for funding for this much needed inclusive and free program.



Community Garden

The John Irving Park Community Garden at Jordan Street Rosehill is well established and well used with many in the community enjoying the amenities.

We now have 27 plots that are fully operational, with a mix of community members and community agencies with a current waiting list of 16 community gardeners.



Bunnings Lidcombe has supported us through the year with donations of tools, seeds and potted annual flowers. A big thank you to Bunnings Lidcombe, for their generosity towards, contributing to the community garden.

Thank you to the generosity of Parramatta City Council in providing an extra block of land. The land was tested for contaminants and the first ¼ of land was found to be contaminated with carcinogenic material. We are currently waiting on Council to remediate the section of land by creating a native reserve for use as a recreational resource with seats and a water feature provided for quiet

reflection. The remainder of land will provide plots, toilet and a green house/potting shed.

The plans for next year will be to apply for a club grant to provide the funding needed to install plots. This will give us the resources to provide more garden plots for various members of the community to engage in gardening and meet their neighbors. There is currently a high demand to garden and a growing waiting list.



The community garden is a great opportunity to encourage community partnerships, friendships and cultivate and educate new gardeners that come from various parts of the world.

We are currently lobbying Local and State governments for funding for a toilet, to open up the garden for use by local schools, aged care facilities and disability services making the garden completely inclusive of the whole community.

Harris Park Neighbourhood Week Event

This year the Harris Park Neighbourhood week network organised four days of events for Neighbourhood Week. The working group met every month to organise this event, there were representatives from various services

 community garden under the shelter and build a bbq for the community
 gardeners, their friends and relatives to have a pleasant place to meet. This
 area will also be opened to community services for meetings or a place to
 take their clients that is private and enjoyable. This will be a project in
 partnership with Granville Tafe bricklaying students.
- We will continue to raise funds in 2015 for Homework Help and Creative Arts program. This program is very popular in the local area for support for primary school student's homework. In the Creative Arts time slot Suzanne is planning on doing simple cooking such as biscuit making and basic hygiene and healthy eating. Something I am sure all the children will enjoy doing.
- We will maintain our efforts in providing the best possible outcomes for our community and our clients.

STUDY BUDDIES/CREATIVE ARTS PROGRAM 2013/2014

During 2013 & 2014 Harris Park Community Centre ran a Homework Help and Creative Arts program. A total of 15 students were enrolled with an average of 9 children attending each session. The Homework program provides assistance to local children ages 8 to 12 years with their homework and creative arts. All students are enrolled in both programs. The programs run twice a week on a Monday and Thursday afternoon. The children all reside in the Harris Park area and attend Rosehill & Parramatta Public Schools. The children came from various cultural backgrounds including: Lebanese, Afghanistan, New Zealand, Turkish, Pakistan & Indian.

The homework is set by the school teacher. The children have 4-6 numeracy & literacy worksheets and a spelling list to complete by the end of the week. Staff provided additional worksheets if the students completed their set homework before the end of the session.

We developed word games for the students to complete on the whiteboard, they enjoyed this very much and it assisted them with their spelling and grammar, they also encouraged the older students to assist the younger students in completing their work. The students took this responsibility on with great pride. Each week a *student of the week* would be nominated by the teacher and students to be rewarded with a prize.

The students benefit greatly from attending the program as most of the parents come from Non-English speaking backgrounds. This program has proven popular with the community and schools in the past. We have had many inquiries requesting that the program be re-established. The program provides great assistance for the children of families who come from NESB as the parents often feel unsupported within their community.

The teacher made observations on the children and saw an improvement in their approach to study. Their confidence grew in their ability to complete their work and develop a positive approach to study.

We were supported in running the program on a regular basis with Volunteers from the community. With their assistance Staff was able to focus on students who needed one to one support in completing their homework.

Rosehill Public School has been very supportive of this initiative, through informing the school community of the program, and supporting Harris Park Community Centre in advertising the centre's other activities.

CREATIVE ARTS:

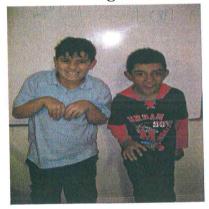

"The thing I like about homework is that it can be really fun & challenging & if I never started coming I wouldn't be as smart as I am now", "I like going to Study Buddies because I learn new things and they help me a lot", "I like interacting with the teacher when I am let down", "I always come to Homework Club because they help me learn and it is so much fun", "I like this place because the teacher helps everyone and we even get some prizes", "I can work and do fun things and make new friends"

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 JUNE 2014

1 Statement of Significant Accounting Policies

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act NSW. The committee has determined that the association is not a reporting entity.

The financial report has been prepared on an accruals basis and is based on historic costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless stated otherwise, have been adopted in the preparation of this financial report.

Leases

Leases of fixed assets, where substantially all the risks and benefits incidental to the ownership of the asset (but not the legal ownership) are transferred to the association, are classified as finance leases.

Finance leases are capitalised by recognising an asset and a liability at the lower of the amounts equal to the fair value of the leased property or the present value of the minimum lease payments, including any guaranteed residual values. Lease payments are allocated between the reduction of the lease liability and the lease interest expense for the period.

Leased assets are depreciated over their estimated useful lives where it is likely that the association will obtain ownership of the asset or over the lease term.

Lease payments for operating leases, where substantially all the risks and benefits remain with the lessor, are recognised as expenses in the periods in which they are incurred.

Lease incentives under operating leases are recognised as a liability and amortised over the life of the lease term.

Impairment of Assets

At the end of each reporting period, the association assesses whether there is any indication that an asset may be impaired. The assessment will consider both external and internal sources of information. If such an indication exists, an impairment test is carried out on the asset by comparing the recoverable amount of that asset, being the higher of the asset's fair value less costs to sell and its value-in-use, to the asset's carrying amount. Any excess of the asset's carrying amount over its recoverable amount is immediately recognised in profit or loss.

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 JUNE 2014

Accounts Receivable and Other Receivables

Accounts receivable are recognised initially at the transaction price (i.e. cost) and are subsequently measured at cost less provision for impairment. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

At the end of each reporting period, the carrying amount of accounts receivable and other receivables are reviewed to determine whether there is any objective evidence that the amounts are not recoverable. If so, an impairment loss is recognised immediately in income and expenditure statement.

Employee Benefits

Provision is made for the association's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee benefits have been measured at the amounts expected to be paid when the liability is settled.

Provisions

Provisions are recognised when the association has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured.

Provisions recognised represent the best estimate of the amounts required to settle the obligation at the end of the reporting period.

Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at-call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts. Bank overdrafts are shown within borrowings in current liabilities on the balance sheet.

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 JUNE 2014

Revenue and Other Income

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue.

Interest revenue is recognised using the effective interest rate method, which for floating rate financial assets is the rate inherent in the instrument.

Revenue recognition relating to the provision of services is determined with reference to the stage of completion of the transaction at the end of the reporting period and where outcome of the contract can be estimated reliably. Stage of completion is determined with reference to the services performed to date as a percentage of total anticipated services to be performed. Where the outcome cannot be estimated reliably, revenue is recognised only to the extent that related expenditure is recoverable.

Accounts Payable and Other Payables

Accounts payable and other payables represent the liabilities at the end of the reporting period for goods and services received by the association that remain unpaid.

Accounts payable are recognised at their transaction price. Accounts payable are obligations on the basis of normal credit terms.
